In the reference 1st, 2nd and 3rd read above, the Secretary (FAC), Telangana Tribal Welfare Residential Educational Institutions Society has submitted the proposal for sanction of New (3) Schools at (i) Venkatapur, (Wazeedu) Mandal, Mulugu District for Girls, (ii) Akkannapet Mandal, Siddipet district for Girls (iii) Munugodu Constituency, Nalgonda district for Boys with classes from V to XII from the academic year 2023-2024 along with budget and posts.

2. Government after careful examination of the matter, hereby accord administrative sanction for establishment of the (3) for Girls at Venkatapur, (Wazeedu) Mandal, Mulugu District, & Akkannapet Mandal, Siddipet district & for Boys at Munugodu Constituency, Nalgonda district with classes from V to XII from the academic year 2023-2024 with Recurring expenditure of Rs.8,82,43,044/- (Rupees Eight Crores Eighty Two Lakhs Forty Three Thousand and Forty Four only) per annum and Non Recurring expenditure of Rs.3,33,00,000/- (Rupees Three Crores Thirty Three Lakhs only).

3. The orders for sanction of teaching and Non-teaching posts will be issued separately by Finance (HRM-II) Department.

4. The Secretary, TTWREIS (Gurukulam), Hyderabad shall take necessary action accordingly.


